Public selection procedure for one permanent position as associate professor in compliance with art. 18, paragraph 1 of law 240/2010

Humanitas University invites applications from outstanding scholars for a position as Associate Professor in GENERAL PATHOLOGY (selection group: 06/A2 Experimental medicine, pathophysiology and clinical pathology).

The appointed Professor will carry out research and teaching in the Scientific-Disciplinary Sector MED/04 - GENERAL PATHOLOGY. The teaching activities will be mainly carried out in the Undergraduate Degree course in Nursing. The research and teaching activities will be integrated with the service provided by the appointed Professor at the IRCCS Humanitas Research Hospital, in the capacity of Researcher.

The work place is in Rozzano - Milano.

Salary and pension contributions are determined according to the applicable laws regarding Academic staff of Italian universities.

Rights and duties are governed by the applicable provisions of law relating to the legal status of the academic staff, as well as the Code of Ethics and Regulations adopted by the Humanitas University.

As part of the selection process, a committee, especially appointed, will evaluate the curriculum and teaching activities carried out by the applicants taking into account the following criteria in the following order:

- a) the number and duration of the teaching activities carried out in Italian academic institutions specifically aimed at the scientific sector under consideration in this call;
- b) the number and characteristics of the teaching activities carried out in English in universities or institutions of higher education specifically related to the scientific sector under consideration in this call;
- c) the possession of a PhD obtained in Italy or abroad, or in the latter case, an equivalent qualification;

d) other teaching assignments in the scientific sector under consideration in this call.

In the evaluation of the scientific production of the candidates, the committee will give prominence to the following criteria in their order of appearance:

- a) coordination activities and / or participation in research groups in institutes of excellence, in Italy and abroad, in the field of experimental immunology, with particular reference to degenerative diseases. Special consideration will be given to the experience in studying the role of cytokines in tumorous environments;
- b) records of studies, researches and consequent non-episodic publications in the field of cellular and molecular immunology, with particular reference to degenerative diseases. Specifically, the value of the h-index for the last five years will be taken into account (source: Scopus) as well as the overall rough IF resulting from publications on PubMed issued from 1 January 2011 to the date of publication of this notice;
- c) the ability to attract national and international funding for research;
- d) originality and innovativeness of the results of scientific production;

As part of the selection procedure, a maximum of 30 publications will be assessed for each candidate.

In order to be considered for the post candidates must hold at least one of the following qualifications at the time of submission of the application:

- a) national scientific qualification (pursuant to art. 16 of Law 240/2010) for the competition sector or for one of the competition sectors included in the same macro-sector and for the functions covered by the procedure or for higher positions, if not already employed in these higher positions;
- b) "idoneità" according to "Legge 210/1998" for the position corresponding to Associate Professor, provided the qualification is still valid;
- c) being employed as associate professors in other Italian universities;
- d) being permanently employed in research or teaching activities at university level outside Italy in positions which are equivalent to those required in this call as determined by the correspondence chart set out in the Ministerial decree 236/2011.

Those who, at the time of submission of the application, have a degree of consanguinity or affinity within the fourth degree, either with the Rector or the Director General or a member of the Board of the University cannot participate in the selection process.

Applications should be written on plain paper according to the model attached to the Rectoral Decree n. 17/2014 (available at page http://www.hunimed.eu/it/lavora-con-noi/) and must be produced, under penalty of exclusion, within thirty (30) days from the day of the publication of the notice in the Gazette - Series IV. If the specified deadline falls on a public holiday, the deadline is the next working day.

The application form, duly signed, under penalty of exclusion, can be sent using one of the following ways:
