

# TAX CODE APPLICATION

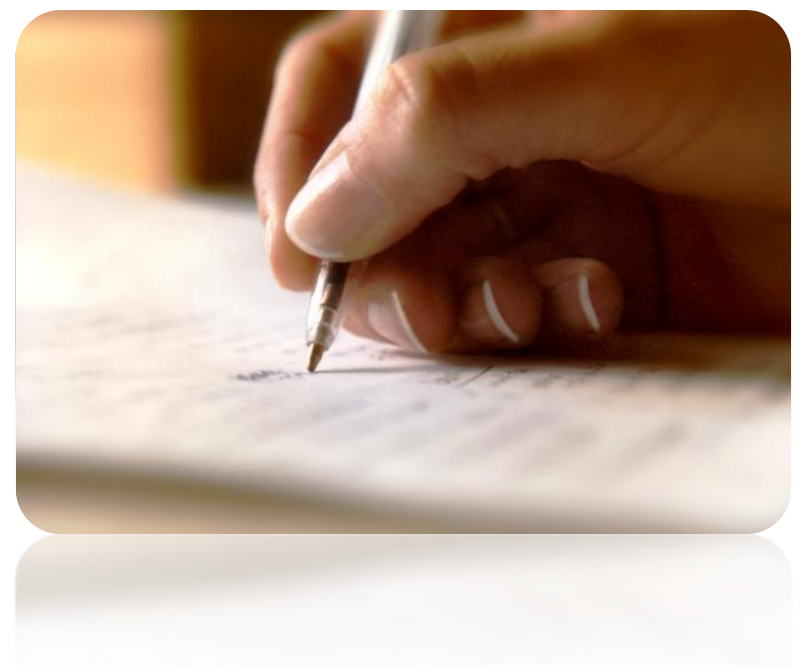


- Tax code (*codice fiscale*) is issued by **AGENZIA DELLE ENTRATE**

- You will have to send us the filled application form and a copy of your passport – page with your personal data + visa + entry stamp
- Sign the form with pen, electronic signature is not accepted
