After the two interesting seminars held last year in a cycle called "Medice cura te ipsum", Humanitas University has decided to offer a training course in interaction with clinical realities, which aims to stimulate reflection on the **ethical** issues related to the life and health sciences.

This course is offered to Medicine and Surgery students as well as Nursing and Physiotherapy students.

The aim of the course is to create a systematic bioethical pathway whose starting point is the knowledge that the technical-scientific skills must always be integrated with a **profound sensitivity** regarding the problems of the **suffering human being** and the sense of **ethical-social responsibility**.

This aim can be achieved through a series of seminars whose method and purpose are:

- The identification of the ethical problems that have emerged in the development of experimental sciences;
- The knowledge of the anthropological and ethical foundations on which healthcare decision-making is based;
- The discussion of clinical cases.

This course includes 16 seminars (May 2017 - June 2020).
The 2-hour seminars will be held on Wednesdays from 1 pm to 3 pm.
