

## **ROTOMAIL ITALY SCHOLARSHIP**

REGULATION FOR THE ASSIGNATION OF ONE (1) SCHOLARSHIP FUNDED BY ROTOMAIL ITALY. THIS SCHOLARSHIP IS RESERVED FOR EU AND EU-EQUATED CITIZENS APPLYING FOR THE FIRST YEAR OF THE SINGLE-CYCLE MASTER'S DEGREE COURSE IN MEDICINE AND SURGERY IN ENGLISH NAMED MEDTEC SCHOOL FOR THE ACADEMIC YEAR 2019-20 (Class LM-41).

### **INTRODUCTION**

In the belief that talented and motivated students deserve to be supported in pursuing academic and professional aspirations, Rotomail Italy has decided to fund one (1) scholarships reserved for EU and EU-equated citizens who intend to enrol in the first year of the Single-Cycle Master's Degree Course in Medicine and Surgery in English named MEDTEC SCHOOL in the Academic Year of 2019-2020 (Class LM-41).

The official source of the Call for Applications for EU and equated citizens is found in Italian on the Humanitas website. This document is provided for the convenience of international students. In the event of disputes, the parties should refer only to the document in Italian.

#### **Art. 1. Value of the scholarship**

Students awarded with this scholarship will receive a total exemption of their university fees.

Awarded students will be required to pay the enrolment fee, amounting to 4,156.00 (four thousand, one hundred, and fifty-six euros), to confirm their enrolment. The amount of University Tuition contribution, equal to 4,000 (four thousand euros), will subsequently be fully reimbursed immediately following the start of the 2019/2020 academic year.

This amount will also be reimbursed to eligible scholarship applicants who decide to renounce their enrolment to Humanitas University while awaiting, or following, the results of the assignment of the scholarships.

The scholarship is automatically renewed each year, up until the completion of the degree, according to the criteria established in Article 3.

## Art. 2. Requirements, evaluation and application criteria

Eligible candidates will meet the following requirements:

- Minimum score of High School Diploma of 90/100. For candidates in possession of a non-Italian Secondary School Diploma, an equivalent score is required, i.e., a score equal to or greater than 90% of the maximum score achievable.
- Admissions Test Ranking Position within the top 50 places.

Scholarships are reserved to EU and EU-equated citizens.

In order to apply, candidates must send the following documents to the email address [info@hunimed.eu](mailto:info@hunimed.eu), with the email subject “Rotomail Italy Scholarship MedTech School”

- Motivation Letter and Curriculum Vitae
- Transcript of the last two years of Secondary School
- Final Transcript of Secondary School Diploma

The deadline to apply is **August 30<sup>th</sup>, 2019**. Applications received after this date, or incomplete applications received, will not be considered for the scholarship.

The scholarships will be assigned considering the following parameters – Entrance Test score, Secondary School Final Grade, Median Grades from the last two years of Secondary School, and the resulting score of the Motivational Interview.

For each parameter, a score will be determined according to the following criteria (Table 1):

Criteria	Score Calculation
Entrance Test Score	Full score
Secondary School Final Grade**	$[(\text{Grade} - 90) / (100-90)] * 200$
Median Grade – Second-to-last Year of Secondary School**	$[(\text{Medial grade} - 6) / (10-6)] * 100$
Median Grade – Last Year of Secondary School**	$[(\text{Medial grade} - 6) / (10-6)] * 100$
Result of the Motivational Interview	From 0 – 600 points

\*\*Equivalent score calculations will apply for foreign diplomas.

**The total score achieved by the candidate will be determined by the sum of the scores of each of the above criteria.**

**The maximum achievable score is 2000 points.**

Eligible Candidates will be invited to sit an interview with a Special Commission. The interview is aimed at determining the motivation and attitudes of the candidates towards the study of the courses included in the curriculum of the degree course.

Candidates can present themselves in person at Humanitas University (Via Rita Levi Montalcini 4, Pieve Emanuele, Milan – Italy) or by videoconference.

The Interview Dates will be communicated to the candidates immediately following the publications of the results of the Entrance Test.

### Art. 3 Requirements for Scholarships Renewal

Scholarship winners of the 2019-2020 Academic Year will have their scholarship renewed annually until the completion of their degree, on condition that they meet the following requirements each year:

- Maintain a grade average of greater than or equal to 27/30
- In compliance with prerequisites, achieve 90% of the University Credits (CFU) assigned to each academic year, as specified in the table below (Table 2)

1 <sup>th</sup> year scholarship	According the procedure specified above
2 <sup>nd</sup> year scholarship	52 credits, to be acquired within 1 <sup>th</sup> year
3 <sup>rd</sup> year scholarship	107, to be acquired within 2 <sup>nd</sup> year
4 <sup>th</sup> year scholarship	159, to be acquired within 3 <sup>rd</sup> year
5 <sup>th</sup> year scholarship	222, to be acquired within 4 <sup>th</sup> year
6 <sup>th</sup> year scholarship	284, to be acquired within 5 <sup>th</sup> year

- Awarded students must complete the required CFU by September (last exams session of the academic year).
- In case awarded students do not achieve the required CFU by the last exam session of the academic year, or their grade average is less than 27/30, the scholarship will not be renewed and the student will be required to pay the full amount of academic fees requires by the Regulations for the Academic Taxes and Contributions
- Awarded students are required to complete the Degree Course within 6 years. However, a further 6-month period is granted (up until the last graduation session of the sixth year of the course), for the sole purpose of obtaining the degree. After this time period, the candidate beneficiary will have to pay the academic contributions according to what is established by the Regulations for the Academic Taxes and Contributions.
